At calendar call each party should be prepared to make known or identify any plea offers, pre-trial motions in need of a hearing prior to trial, time estimates for trial, interpreter requests, filed *Leaves of Absence*, and any matters which might impact the trial. The Court will also be available to take pleas at Calendar Call.

CRIMINAL PLEAS AND MOTIONS

Any attorney or unrepresented party who seeks to have a pending motion heard on **Monday, January 22, 2024** must notice it for a hearing and serve opposing counsel with said notice no later than **Friday, January 12, 2024**.

The Court will hear pleas on **January 22, 2024 beginning at 9:00 A.M.**

Motions not heard on or before **January 22, 2024** may be deemed waived unless a later hearing is expressly authorized by the Court.

Pleas after **January 22, 2024** may be considered non-negotiated, unless expressly permitted by the court as negotiated pleas.

CIVIL PRETRIAL CONFERENCE

All parties scheduled for a Civil Jury Trial shall appear before the Court on the **January 23, 2024** Calendar for a pretrial conference in accordance with O.C.G.A. § 9-11-16.
