PLEAS AND MOTIONS


Prior to June 13, 2022, any attorney or unrepresented party who seeks to have a pending motion heard that relates to a criminal case on this calendar must notice it for hearing on Wednesday, June 23, 2022 and serve opposing counsel with said notice.

The Court will hear pleas and motions on Wednesday, June 23, 2022 at 9:00 a.m., in person.

Motions not heard on or before June 23, 2022 shall be deemed waived unless a later hearing is expressly authorized by the Court.

Pleas after June 23, 2022 shall be considered non-negotiated, unless expressly permitted by the court as negotiated pleas.
