At calendar call, each party should be prepared to make known or identify any plea offers, pre-trial motions, time estimates, interpreter request, and any matters which might impact trial.

Trial Motions will be heard following calendar call, **Thursday, November 4, 2021**.


***Defense attorneys must file their criminal motions before 5:00 p.m. Wednesday, October 27, 2021.**

***Defense attorneys must file a notice of any motion with the Court Clerk and serve the District Attorney's office with these motions and notices of hearing so their pre-trial motions can be heard. Any outstanding motion not heard by Thursday, November 4, 2021 shall be waived.**

Any signed-up plea cases will be concluded on Thursday, November 4, 2021. In person pleas will be taken beginning at 9:30 a.m.. Virtual Jail pleas will begin at 1:00 p.m.. Any plea entered after November 4, 2021 will be a blind plea.

This is a 2-week Jury Trial Calendar begins at 9:00 a.m. on November 8, 2021. Unless instructed otherwise by the Court, every case is on a 4 hour call. No one should report for trial until notified by the Court.
