Any attorney or unrepresented party who seeks to have a pending motion heard that relates to a criminal case on this calendar must, file said motion by no later than July 25, 2025, notice it for hearing on August 4, 2025, and serve opposing counsel with said notice.

Motions not heard on or before August 4, 2025 shall be deemed waived unless a later hearing is expressly authorized by the Court.
