Any attorney or unrepresented party who seeks to have a pending motion heard on Friday, May 9, 2025, must notice it for a hearing and serve opposing counsel with said notice no later than Friday, May 2, 2025.

The Court will hear pleas on May 8, 2025, and May 9, 2025, if needed, beginning at 9:00 A.M.

Motions not heard on or before May 9, 2025, may be deemed waived unless a later hearing is expressly authorized by the Court.

Pleas after May 9, 2025, may be considered non-negotiated, unless expressly permitted by the court as negotiated pleas.
