The Court will hear pleas on Tuesday, June 9, 2026, at the conclusion of the Motions calendar.

Motions not heard on or before Tuesday, June 9, 2026, may be deemed waived unless a later hearing is expressly authorized by the Court.

Pleas after Tuesday, June 9, 2026, may be considered non-negotiated, unless expressly permitted by the court.
