All trial motions will be heard on <u>February 24, 2025</u>, unless otherwise directed by the Court. <u>Any outstanding motions not heard on February 24, 2025 shall be deemed waived, unless otherwise directed by the Court.</u>

Any plea cases already signed and ready at the calendar call shall be taken that day, unless otherwise directed by the Court. If attorneys announce their cases will plea, the attorneys and defendants are to remain in court that day to sign up and take the plea case. Any plea cases taken after February 24, 2025 will be a blind plea, unless otherwise specifically directed by the Court.
