All Jail inmates and bonded defendants will appear in person for calendar call at 9:00 a.m. All attorneys are to appear in person, unless otherwise specifically directed by the Court.

At calendar call, each party should be prepared to make known or identify any plea offers, pre-trial motions, time estimates, interpreter requests, leaves of absences, conflicts, and any matters which might impact trial.

All trial motions must be filed prior to November 7, 2025, along with a notice of hearing placing it on the calendar for November 7, 2025. All trial motions will be heard on **November 7, 2025**, unless otherwise directed by the Court. **Any outstanding motions not heard on November 7, 2025 shall be deemed waived, unless otherwise directed by the Court.**

Any plea cases already signed and ready at the calendar call shall be taken that day, unless otherwise directed by the Court. If attorneys announce their cases will plea, the attorneys and defendants are to remain in court that day to sign up and take the plea case. **Any plea cases taken after November 7, 2025 will be a blind plea, unless otherwise specifically directed by the Court.**

This is a two-week jury trial calendar, beginning at 9:00 a.m. on **November 17, 2025, AND on December 1, 2025.** A list of those cases that are to report on Monday, November 17, 2025 will be sent by email to the attorneys prior to the start of the calendar. If you do not receive this email, or if you are otherwise instructed by the Court, all cases are on 2-hour call during trial weeks.
