4. Confirmation that deadline to accept a negotiated plea is **FRIDAY, JUNE 6, 2025, UNLESS OTHERWISE NOTED** on Exhibit "A;"
5. Anticipated length of trial; and
6. Any possible pretrial issues;
7. And calendar position number.

Motions shall be scheduled if filed. All motions shall be filed no later than **WEDNESDAY, MAY 7, 2025. ALL DAUBERT MOTIONS MUST BE FILED BY MAY 7, 2025.**

Pleas for any cases on the JUNE 2025 Jury Trial Calendar will be on **FRIDAY, JUNE 6, 2025, at 9:00 a.m.** Upon request, there may be other opportunities to enter into a plea, prior to **FRIDAY, JUNE 6, 2025.**
