ORDER SCHEDULING OPTIONAL APPEARANCE FOR PRETRIAL
INTERVENTION CASES

The attached listed cases (Exhibit "A") entered into the Pretrial Intervention (hereinafter "PTI") program. As a condition of each PTI agreement, the enrollee paid \$300.00 to be deposited into the DATE fund. It is hereby ordered, however, that any funds originally collected and designated to be deposited into the DATE fund shall now be designated as "Drug PTI Program Fees." Said fees shall be deposited into Account #10020002-341111. Funds collected as "enrollment fees" shall be deposited into Account #10020320-341190.

Should any Defendant listed in Exhibit "A" object to the aforementioned transition of DATE funds into "Drug PTI Program Fees," they may formally appear on the 4th DAY of November, 2025, at 8:30 a.m., Courtroom 2D, of the Fayette Justice Center, One Center Drive, Fayetteville, Georgia 30214. Any such appearance shall be VOLUNTARY and Defendants listed in Exhibit "A" ARE NOT REQUIRED to appear on the aforementioned date.

FOR ALL CASES FOR WHICH THE DEFENDANT DOES NOT APPEAR, THE CASE SHALL BE SUCCESSFULLY TERMINATED FROM PTI, ALL CASES ABLE TO BE CLOSED SHALL BE CLOSED, AND THE CLERK SHALL TRANSITION AND DEPOSIT ALL AFOREMENTIONED FUNDS AS DIRECTED IN THIS ORDER.

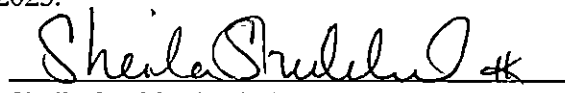
